### WHY CHOOSE MAURITIUS?



**Prime location:** Situated on the historical spice route, Mauritius connects Africa and Asia seamlessly. The GMT+3/4 time zone makes it perfect for European companies, with many from France, the UK, and beyond establishing a base here. Major firms like the Big Four have also chosen Mauritius to serve the EMEA market.



**Multilingual workforce:** Mauritius boasts a high literacy rate (91.9%) according to the latest stats 2022, among the highest in Sub-Saharan Africa. English and French are the primary languages of business, ensuring smooth communication and operations locally as well on the global market.



**Tax advantages:** Enjoy a favourable tax environment with a flat 15% corporate tax rate and no taxes on dividends, capital gains and repatriation. There are also increasingly tax incentives such as 5 – 8 years of tax holidays for innovative sectors in Tech and the Pharmaceuticals. The standard VAT rate is 15%, and Double Tax Avoidance Agreements exist with several countries including India, Luxembourg, and Monaco.



100% foreign ownership allowed: Mauritius allows for hassle-free remote business establishment with full foreign ownership (100%), although some company structures may require a local director. This could manage your business entirely remotely, you can appoint a Mauritian management company to handle operations on your behalf.



**Modernisation:** Urban developments such Moka Smart City offer state-of-the-art facilities, ensuring businesses have access to a progressive and well-connected work environment. Robust internet infrastructure with 100% fibre coverage and the implementation of modern transportation systems like trams further enhance accessibility and solidify Mauritius's commitment to advanced business infrastructure.



**Ease of doing business and innovation:** Mauritius is renowned for its straightforward business setup process and commitment to innovation. It ranked first in Sub-Saharan Africa and 57th globally on the Global Innovation Index. Starting a business is easy, taking only 4.5 days on average, according to the World Bank's Doing Business Report (2020) whilst the OECD average hovered around 9.2 days and 21.5 days for the sub-haran Africa average.



**Optimal residency and citizenship options:** The Henley Residence Program Index rates the top residence by investment programs worldwide, assessing their reputation and value. Updated yearly by experts, it helps individuals and families find optimal residency and citizenship options. **Mauritius ranks 15th in this index.**

## **HOW TO ESTABLISH YOUR BUSINESS IN MAURITIUS**

#### Investor-friendly company options

The Companies Act 2001 and the Financial Services Act 2007 outline the following options:

Global Business Company (GBC): Ideal for international businesses, offering tax breaks and requiring a Global Business License.

Authorised Company (AC): Suited for foreign-owned businesses operating outside Mauritius.

Domestic Company: Best for businesses within Mauritius, providing a simple and adaptable structure. Dependent on the choice or requirement based on the above, then a choice of the traditional structure can be made in terms of limited by shares, public or privately traded, sole owner, partnership, etc. Mauritius allows remote business establishment without a local partner. Depending on the chosen company type, a resident director might be required though. Management companies based in Mauritius can be designated by the owner(s) to run the company on their behalf in Mauritius without them having to set foot in the Mauritius.

## A STREAMLINED INCORPORATION PROCESS

- 1. Company name selection with address: Choose a unique and available name with a physical
- 2. Document preparation: Gather required documents, including director's residency proof, financial
- 3. Registration and fee: Submit documents and fees to the Corporate and Business Registration Department (CBRD).
- 4. Certificate of incorporation: Receive the certificate within 5 working days upon verification.
- 5. Additional registrations: Some industries require additional registrations with relevant authorities.


## OPERATING YOUR BUSINESS IN MAURITIUS

- **1. Secure a registered office:** Every business needs a publicly known address for official communication. This can be your management company's address, or you can choose a physical or virtual office space.
- **2. Maintain compliance:** Stay in good standing with the Mauritius Revenue Authority (MRA) by filing reports regularly.
- **3. Obtain permits and licenses:** As with any business activity, relevant permits will have to be obtained such Building and land use permit, VAT registration from the MRA, to name a few,
